UPDATED PROPOSED TIMELINE

- ❖ **May 2024 – Principal Appointed to New K-8.**
- ❖ **June-August 2024 – New Principal facilitates school and mascot naming process.**
- ❖ **August/September 2024 – BAC Meetings continue to finalize recommendations on boundary scenarios.**
- ❖ **September/October 2024 – Public Information Meeting on Results of Boundary Advisory Committee**
- ❖ **November 2024 – Present Recommendations of the Boundary Advisory Committee.**
- ❖ **November 2024 – Board Adoption of new K-8 Boundaries, School Name and Mascot.**
- ❖ **August 2025 – School Opens.**



Guidelines & Methodology

Methodology – Primary Variables:

- ❖ Use Natural Boundaries (Bridges, Waterways, Major Thoroughfares/Roadways)
- ❖ Current Capacity and Utilization Within the Study Area Impacted (LOS- Level of Service)
- ❖ Address Growth (Current and Projected Planned Development)
- ❖ Portable Reduction Act - (Impacts LOS; Address Safety-Age/Security-Hardening)
- ❖ Geographic Proximity
- ❖ Transportation Efficiency/Logistics (Impacts on Routing, Costs, Etc.)
- ❖ Safety Considerations (Hazardous Walking Conditions Within a Two-Mile Radius, Etc.)
- ❖ Avoid Division of Students Within the Same Neighborhoods/Street
- ❖ Avoid Multiple Moves – Moving Impacted Students in a Study Area Twice
- ❖ Programmatic Equity – (Pre-K and Specialized Program Opportunities for all Elementary Schools)



04.24.24 BAC Meeting Team Reports

Team Pink – Glenn Scharf:

- ❖ New K-8 Boundary Scenario : I-75 west border, north border along SR 72 then north along the FPL Transmission Line with west border along Misty Creek development, including Saddle Creek in new K-8 boundary.
 - This Scenario suggestion was deemed not feasible due to this area having a K-8 site within the Hi Hat Ranch Master Development Order (MDO). This development has already been approved for it's first Village Rezone. This would require students to be redistricted twice. A map is provided to show this suggested Scenario 4 with this future school site.

- ❖ Request: Area development information including the students currently living in Skye Ranch and projected student for a five-to-ten year period for each school.
 - As of our 40-Day Enrollment Counts, there are 222 K-8 students living in Skye Ranch.
 - Projected Students from Development over 5-10 Years for Each School:
 - Ashton = 0 students
 - Lakeview = 15 students
 - Wilkinson = 8 students
 - Sarasota MS = 6 students
 - Central County K-8 = 274 students

Team Green – Taylor Mock:

- ❖ New K-8 Boundary Scenario: Move more students from east off Clark instead of west of I75 - Proctor Rd from I75 southeast to SR72.
 - This Scenario suggestion is included in the maps and data for Scenario 3.

- ❖ Question: Grade level for potential grandfathered students?
 - Determined by the Board.

- ❖ Question: Grandfathered or first Choice for choice to current school?
 - Determined by the Board.

- ❖ Question: Proximity consideration for redistricting area?
 - More clarification is needed to answer this question.

Team Orange – Ali McCarthy:

❖ New K-8 Boundary Scenario:

- i. Redistrict to Wilkinson Elementary: Sawyer Rd west border, south to SR 72, north on McIntosh to Proctor Rd north border, east to Cattlemen Rd, north to Bee Ridge Rd.
- ii. New K-8 or Wilkinson?
- iii. I75 west border due to massive growth east of highway.
- iv. Look at neighborhoods north of Clark and east of highway.

➤ This Scenario suggestion is included in the maps and data for Scenario 3.

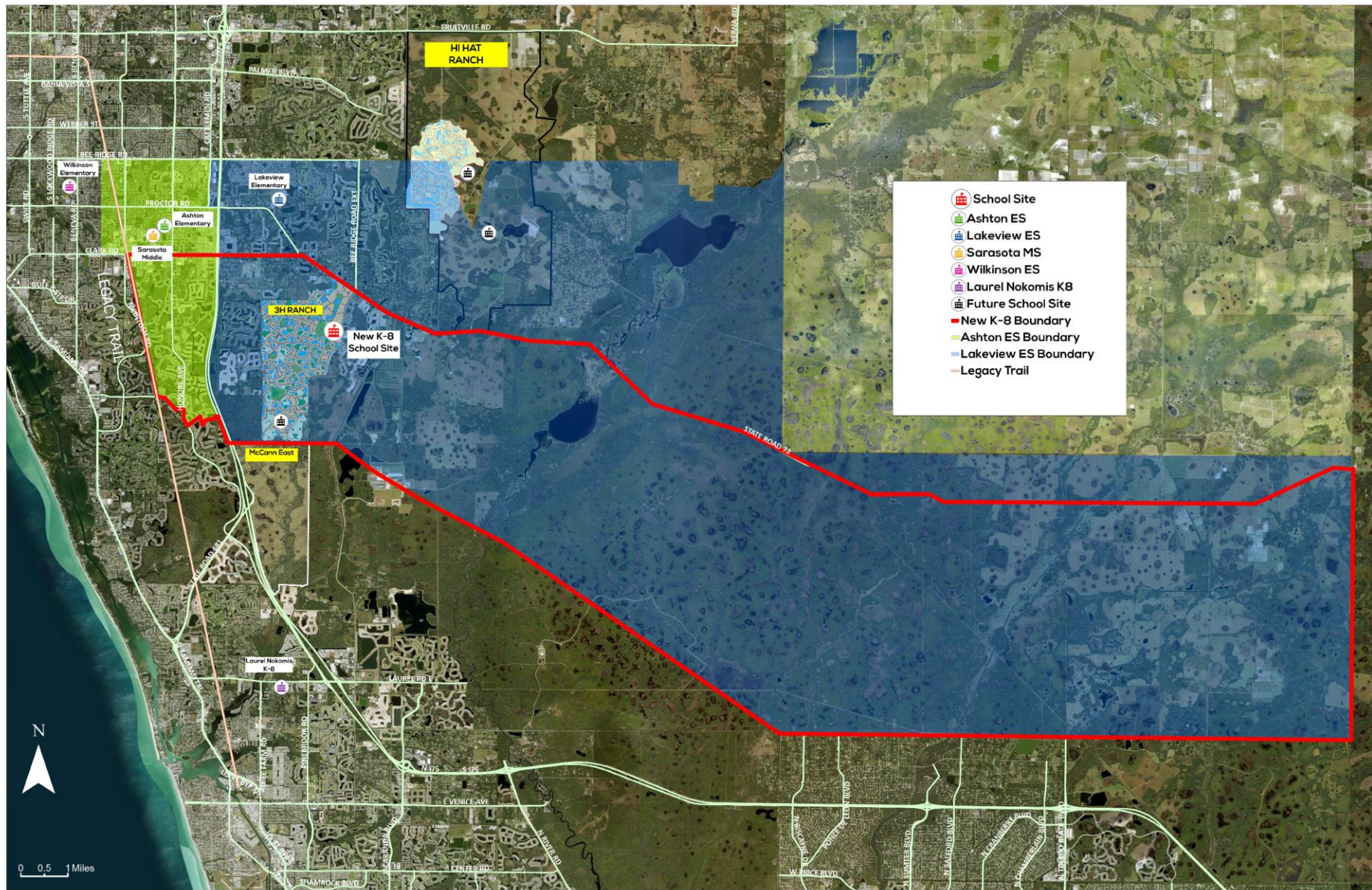
❖ Request: Number of students that will naturally go to the new K-8 but are currently reassigned because new school is not built yet.

➤ There are currently 14 students attending Ashton Elementary that are on reassignment and live in proximity to the new K-8. 6 of those are 5th graders that will begin middle school in August of 2024. 8 are K-4 students.

❖ Question: Number of students projected to attend the new school from the 3,000+ homes in Skye Ranch?

- Skye Ranch Phase 1 – 1,413 Approved Units - 1,300 Built = 205 K-8 Students
- Skye Ranch Phase 2 – 2,037 Approved Units – 0 Built = 295 K-8 Students

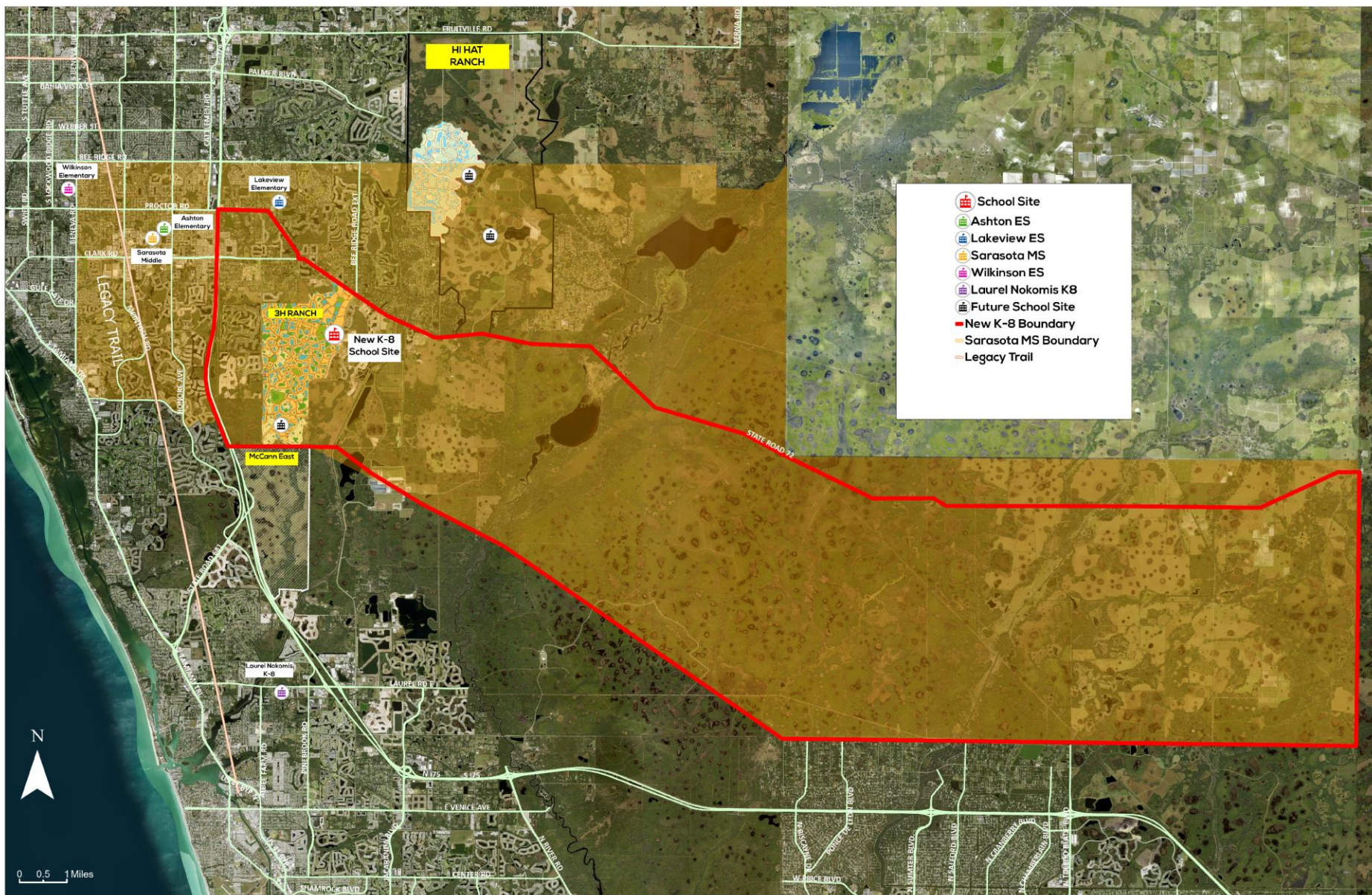
