# President's Message

Thank you to everyone who attended the special board meeting on May 16<sup>th</sup> and the regularly scheduled board meeting on May 30<sup>th</sup>. Whether in person or on Zoom, I appreciate you taking time to participate.

On May 16<sup>th</sup>, the board acted to fill the vacancies caused by Russ Gill's resignation. We appointed Ehren McGeehan, the fourth candidate in the election, to the remainder of Russ' term. We elected me to fill Russ' role as President and elected Curt Gilroy to assume the role of Secretary, my former role.

At the meeting on May 30<sup>th</sup>, the board made several important decisions.

We approved a request to replace patches of turf outside the community center. The original cost was estimated to be \$1520 but the Landscape Committee reviewed the turf conditions and recommended the patching could be much less extensive and therefore much less expensive (\$300). In addition, the board approved the removal and replacement of a hedge along Turtle Rock Boulevard at the south end of the community, at a cost of \$4900.

We also approved the Treasurer's and the FIRRM's recommendation to appoint Centennial Bank as the bank for the Association. This provides much more control over our funds and is a great step forward. The board is also asking the FIRRM to refine and publish our compliance policies to ensure consistent enforcement and wider awareness of the compliance policies and how they are enforced.

Finally, we appointed Ehren McGeehan to the role of board liaison to the FIRRM.

The Landscape Committee recommended the formation of a task force to consider how best to meet the needs of the pickleball players in Turtle Rock. This is a complicated and important issue for the community and we need volunteers who hold various opinions and perspectives to come up with the best solution for the community. # Change in HOA Banking Services

Throughout the past few months, the Board and FIRRM have determined that our current banking arrangement does not meet our needs. We have been frustrated and disappointed with the Truist Bank lack of responsiveness and urgency for our concerns. Thus, in early April a Request for Quotes for Banking Services was sent out to find a new bank that can best support the TR HOA needs. Five banks were contacted to secure the most efficient and effective banking services while maintaining sufficient liquidity and protection of all the HOA funds.

Two banks replied with a comprehensive response for all services requested. New and enhanced banking services will include:

- Interest paid on the operating bank account
- Temporary investment of funds (sweeps) not needed for immediate vendor payments
- Approval/verification of all payment demands on the operating checking account
- On-line, view only bank account access for HOA Board members
- Active HOA banking division led by a bank officer who holds a Community Association Manager license
- Cash management assistance

Both banks were interviewed to determine the benefits of working with each institution. Based on the response review, interviews and follow-up conversations the FIRRM has recommended Centennial Bank as our future banking partner. The Board has approved entering into a banking agreement with Centennial Bank. Implementation with Centennial Bank will begin in early June.

For now, there is no impact on residents other than improved security and interest income. Lockbox/Assessment payment processing will not change at this time. All funds collected through the current payment processing will be transferred on receipt to the new bank.

New payment information will be sent to residents this fall along with information on the 2025 assessment fees.



Turtle Rock hosted the Big Red Bus for a blood drive on May 17<sup>th</sup>. Darcy Bessette, the coordinator from One Blood, wrote to thank Nanette and Nan for coordinating the drive, and also to thank all the donors who came out that day. She shared the following information:

The recent blood drive resulted in 19 units of blood. That's a great start as we projected a goal of 10 units!!!

- Each donation can save up to three lives so that means 57 patients could benefit from the lifesaving efforts of blood donors at Turtle Rock.
- The blood donated at our blood drive was likely transfused into a patient within 48 to 72 hours. The turnaround is that fast and is that constant.

#### The Big Red Bus will be back on Friday, August 2, 2024. Mark your calendars!

She also shared some comments they have received from recipients of donated blood. These comments came through their "Message My Donor" program, where blood recipients or their families can send a message to the donor who selflessly gave their blood to help others. In case you think it doesn't matter -

- Dear Donor, thank you so much for your contribution. My mother received countless blood and platelets due to her untreatable and advanced form of blood cancer. These donations of blood and especially platelets were her lifeline in the final weeks when her body could not produce more. Every infusion gave her a little precious extra time with my sister and me. Before Mom passed, she gave me your donor tag and asked me to thank you on her behalf. We are forever filled with gratitude for generous donors like you who give so selflessly.
- Your gift is keeping me alive. Thank you, from the bottom of my heart. I have a condition called aplastic anemia, which basically means that my bone marrow has been unable to produce healthy blood. I am undergoing treatment and until it fixes my problem, I am dependent on transfusions. I have given blood many, many times in my life, but never imagined that I would need transfusions. Please keep giving! And of course, I will start giving again as soon as I am able. Thank you!
- Hello, I wanted to take the time to thank you for your donation. Not to put it lightly but, it literally saved my life. I had a baby and shortly after, I hemorrhaged very badly and lost over half my blood volume, leaving me unable to hold my baby on his first day. But here we are, over a month later and I am healthy and have a happy and healthy baby. Thank you for your donation. Because of you, I am able to sit here and hold my baby while writing this message. Thank you again, God bless you: )

# Photos tell the story of our ponds

Waiting... and waiting... for rain.

Turtle Rock is experiencing very dry weather at the time of this writing. When conditions approach drought levels, Turtle Rock stormwater retention ponds show the strain. Banks are wider, water is lower, and previously hidden plants may show up in the shallows and along the banks. If the water is particularly warm, oxygen levels tend to be reduced, and some fish may die. NAC monitors conditions and takes measures to maintain pond appearance and health. But just as NAC has postponed the installation of 3,000 new aquatic plants until pond levels and weather improve, the team also exercises restraint in assigning vendors work that may prove to be unnecessary once water levels rise. On the positive side, the ponds should have ample capacity for major summer storms.

# The Deadliest animal on earth.

Which animal counts as the most dangerous in the world depends on which metric you're using, but going by pure annual body count, mosquitoes win by a large margin. By transmitting severe diseases such as malaria, dengue fever, Zika virus, and West Nile virus as they feed on human blood, the tiny pests are responsible for around 725,000 deaths each year.
