



as soon as possible. We have to have the annual Members Meeting, we have to notify residents via mail so if we don't achieve a quorum for the February 27 meeting, we will have to keep trying until we do. Please send in your yellow proxy. Thank you!

There were two funding requests presented to the board: one to purchase and install a generator for the community center and one to conduct an inspection of the stormwater management control structures. The inspection was approved at a cost of \$1,500. The Board discussed the generator, which most agree is a good idea and would allow the offices there to continue to conduct business during a power outage, but the idea was tabled to allow for more time to discuss the idea and decide if we want to pursue other options.

The Board also voted to change the fees charged for bar codes. New owners and new tenants will continue to pay \$50 per bar code. Existing residents and tenants will have their fee reduced to \$20. Hopefully that eliminates a pain point for residents who need a new bar code. The Board also approved a resolution allowing the Association to obtain a new credit card from Centennial Bank to replace the cards that are expiring or are associated with banks we no longer do business with

#### **Trees are an Important Natural Asset**

Trees play a central role in Turtle Rock, contributing not only to the aesthetic appeal of our neighborhood, but also to the health of our environment. Homeowners and the Association, therefore, share a joint responsibility to maintain and, when necessary, replace the trees in alignment with Turtle Rock's governing documents.

Turtle Rock's documents specify the minimum number and types of trees required for each property. These requirements vary depending on the lot size, but generally include a thoughtful combination of hardwood trees and palms. Adhering to these requirements is not only a matter of community pride, but also an obligation for homeowners. These requirements are stipulated in the *TURTLE ROCK Standards and Criteria for New Construction*, and homeowners can find these requirements in the table on p. 45 of the *Turtle Rock Owners' Manual*.

If you are still uncertain about the tree requirements for your property, the Architectural Review Committee (ARC) and the Management Office at the Community Center are excellent resources. They can provide guidance on the number and types of trees your lot requires and ensure any replacements align with Turtle Rock's standards.

Over the years, age, disease, and storms have claimed many of our seasoned trees. While these losses can be disheartening, they also present an opportunity to reimagine and reinvigorate our landscapes. Proper tree maintenance and replacement ensure that our community retains its lush character, supports wildlife, and enhances property values.

From a landscaping perspective, trees provide shade, reduce noise, and serve as natural boundaries between homes. The shade from mature trees can make outdoor spaces more inviting while also offering privacy and reducing our air conditioning bills. Additionally, the diverse mix of hardwoods and palms outlined in the Turtle Rock Owners' Manual ensures a visually appealing balance across the community.

#### Trees are an Important Natural Asset (continued)

Environmentally, trees are indispensable. They improve air quality by absorbing carbon dioxide and releasing oxygen, reduce stormwater runoff, and provide critical habitats for birds and other wildlife. Replacing ailing or removed trees with appropriate species helps preserve these benefits for future generations.

It is important to note that the Association cannot ask homeowners to do something that it would not do itself. With that in mind, the Landscape Committee has received approval from the Board to replace trees in the common areas that came down during the recent storms. Pruning healthy trees is also important to not only maintain their overall health and aesthetic beauty, but also to avoid potential further storm damage to your or your neighbor's property. Trees are *that* important to both the community and the environment. The Natural Assets Committee is also supportive of this initiative.

By maintaining and replacing trees as needed, we honor the shared vision of Turtle Rock as a vibrant, green community. Let's work together to ensure that our tree-lined streets and verdant landscapes remain a defining feature of our neighborhood for years to come. # ARCHITECTURAL REVIEW COMMITTEE (ARC) MEETINGS FOR 2025

The ARC meets monthly to review application requests submitted by homeowners for any change to the exterior or landscaping of their homes. All meetings start at 9 a.m. at the Community Center. The meeting schedule for 2025 is as follows:

Applications are to be submitted to the Management Office no later than the 15th of every month by 1 p.m., with no exceptions. Results will be posted to the website soon after the ARC meeting.

Emergency applications involving ongoing property damage or safety hazards will be considered on an expedited basis after contacting the Management Office.

#### "Watchdog Report"

Well this one hits a little closer to home. One of our own TR clubs (groups) was blasted an email to all its members. The group and members requested anonymity, but the situation is real. The scam email read like this:

Dear Steve.

How are you doing? Are you available for assistance? I am out of the state now, and I have absolute confidence in you to handle this. The [name of group being scammed] needs to purchase gift cards to make donations to Veterans in Hospice and Palliative care units to buy coronavirus disease (COVID-19) prevention items. I'm responsible for the reimbursement. Would you like further information? I wish you blessings and happiness In 2025!!!

Sincerely, [name of prominent member]

#### I responded back that I'd be happy to help. Send me additional info and got this:

Steve, Thank you for responding back. I sent you a double response, you may need to check your spam mail. Kindly write me back as soon as possible. I currently cannot place a call because of non-available cellular service in Lanai Islands (Hawaii). I contacted you to help with this, as I trust you enough to complete this task as this is quite easy and straight forward. Kindly purchase any of eBay, Apple, Master Card gift cards for the donation pledged to Veterans at Hospice & the Palliative Care Unit on behalf of the [name of the TR group being scammed]. You can purchase the cards at any store near you (Walmart, Target, Walgreens, CVS, Dollar General e.t.c) in your current location for physical cards.

You will take a clear picture of the cards (front and back) to the email from the Director. The Director specifically instructed that the cards should be sent through email. This is because of the rule of Social distancing. Because of the time frame, I will need it to be done today or tomorrow. After purchasing the cards, send me a receipt for purchase from the store. You will keep the cards safe till I am back. I will be liable for reimbursement and also, let me know if a check is okay. I wish you a happy holidays in health and happiness In 2025!!!

Once the scammer has the numbers on the card, it's as good as having the card itself. They're gone and so is your money. It's an old scam, but it still works. It deeply saddens me to report such scum exists, but knowledge is power. When in doubt, call the Sherriff's department and ask.

#### **Landscape Committee Updates**

Three hurricanes within 8 weeks last summer was a tall order for keeping the property looking good. We are thankful that despite taking a direct hit from Milton, not more property damage was incurred here—so many areas are still trying to recover. We lost more large trees, but hurricane clean-up was completed early December, new flowers planted at our entrances and in front of the community center, and the annual mulching event took place. The Board approved enhancements in December that we hope will be implemented within the next few weeks:

- the hedge along PRP between our entrance and Botanica has been declining for years, and has invited trespassing. The entire line of existing shrubs will be replaced with new plantings in order to fill the gaps and create a continuous green living wall;
- the area at our south wall—going east from the entrance—is also in need of refurbishment, especially since two large oaks had to be removed after being struck by lightning. Shrubs in an arrangement similar to the wall plantings along Palmer Ranch Pkwy, plus two trees, will be installed.
- the landscape lighting at both our entrances is unsound and looking shabby. The committee's proposal for replacement was tabled after Milton struck and there were more vital tasks at hand. This project is a reserve expense that has been fully funded, meaning we all have been saving up to replace this feature for our entrances for 15 years. The vendor is ordering parts and hopes to begin installation in March.

A rolling net was ordered for the pickleball lines painted on the basketball court. It is to be rolled back along the fence and out of the way when not in use. Also, new cameras have been installed so that use of this multi-purpose court can be monitored for use, providing information as to how frequently each type of sport is being played here.

The non-functioning call box at the north gate, humorously clad with wrapping paper and a bow during the holidays, has been removed—thanks, AZ! This is certainly an improvement over a black garbage bag.

Finally, in the upcoming months, the committee will be ready to make a recommendation to the FIRRM and Board to replace all our streetlights. As the summer hurricanes proved, this vital infrastructure has also outlived its useful life and needs to be replaced. The committee has identified several qualified sources to provide us with a complete solution that will be fully warranted for 7 years and is expected to last 20. For several months, two different prototypes have been lighting the Boulevard: one at the Blvd and Benchmark, the other on the Blvd between Deerbrook and Sabal Lake. That sample is a newer design which incorporates the solar panel at the top of the fixture, eliminating the need for the arm off the pole. This makes for not only a cleaner look, but a more wind -resistant installation. Two additional prototypes from a competitor were just installed at their expense—one along the Boulevard between Meadow Rush and Sweetmeadow, the other between Wildflower and Little Brook courts. Please take a look as you are driving on the Boulevard during the night.

#### From The West Corner Of...

#### Mind your "P"s and "Q"s

Anyone who "minds their p's and q's" is known for acting on their best behavior, but what do those two letters stand for? Polite and quiet? Proper and quaint? Peas and uh... qarrots? We won't take liberties with the spelling of "carrots," and we can further confirm that none of those options is correct. However, there are a few origin stories for this perfectly quirky turn of phrase.

The Oxford English Dictionary records examples of these letters in print as early as 1602, though "p's and q's" were sometimes written as "Pee and Kue." "To be on one's p's and q's" and variants of that phrase meant to be on one's best behavior. The exact wording of "mind your p's and q's" was first documented in the 1756 book The Life & Memoirs of Ephraim Tristram Bates.

While lexicographers and dictionaries can trace the printed citations and usages of words and phrases, they often don't reveal how these phrases originally came to be. With "p's and q's," there are several possible origin stories, but none rises above the rest. It's possibly related to the similarity of the appearance of "p" and "q" in penmanship and a warning to avoid mixing them up; a similar story is related to printers mixing up the letters when typesetting. A completely different theory is based on the idea that bartenders used to keep running tabs of the number of pints and quarts drunk by their patrons (or told the patrons to "mind their own p's and q's"). A fourth and final purported origin story is that "p's and q's" translates to "pleases and thankyous," as the latter part of "thank-you" sounds like the letter "Q."
